# **Apply for a Farm to School Grant Today!**

In 2023, USDA will award approximately \$12 million in grants through a competitive process that provides bonus points to projects operated by and serving communities that are underserved, marginalized, or adversely affected by poverty and inequality. USDA invites all eligible and interested organizations to apply by January 6, 2023.

Schools, farmers, and other organizations that help produce or serve meals to kids through USDA's child nutrition programs are eligible to apply for the USDA Farm to School Grant.

The upcoming round of grants will build on the \$70 million of investments in farm to school that USDA made this year, which includes the first-ever non-competitive grants for states to assist their child nutrition programs in using more local foods.
