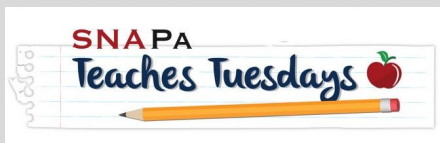

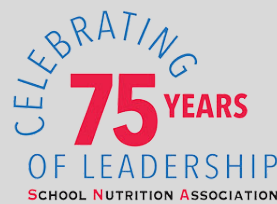

SNAPA members had the opportunity to participate in the 2021 Virtual Legislative Action Conference, March 8-10, 2021. Attendees participated in a series of workshops and sessions aimed at building advocacy abilities and providing up-to-date legislative information on school nutrition across the nation. Special guests even included Secretary of Agriculture, Tom Vilsack and renowned actor Matthew McConaughey!

PA Harvest of the Month Recipe Standardization Grants

The Pennsylvania Department of Education (PDE), Division of Food and Nutrition is taking applications for a grant opportunity to recruit schools to be involved in development of nutritious and tasty recipes that incorporate Pennsylvania agricultural products and appeal to students' taste preferences. Successful applicants will be required to develop and test two recipes featuring specific items from the Pennsylvania Harvest of the Month program calendar. The amount of funding available is up to \$8,000 per school food authority. Awards will be made to ten school food authorities. Each school food authority may submit no more than one application.
