SNA Report: SY2022-23 Participation Drop

The School Nutrition Association's (SNA) latest School Meal Participation Tracker report details participation and meals served during School Year (SY) 2022-23, as compared to prepandemic years and SY 2021-22, when federal pandemic waivers allowed all schools to offer free meals to all students.

Notably, the loss of free school meals for all students has contributed to a significant drop in ADP. Comparing preliminary SY2022-23 data to SY2021-22 data, the report finds a: 6.44% drop in lunch ADP

8.67% drop in breakfast ADP

SNA is advocating for offering free meals to all students without an application to allow more students to eat nutritious school lunches and breakfasts, proven to contribute to improved health and academic outcomes. <u>Access the full report here</u>.

Pennsylvania Farm to Child Nutrition Regional Gatherings



oin us this October, National Farm to School Month, at a Pennsylvania Farm to Child Nutrition gathering. These ½–day sessions will be held in the Pittsburgh area and Harrisburg.

Sessions will include presentations about Pennsylvania Harvest of the Month (PA HOM), engaging students in farm to child nutrition activities, funding farm to child nutrition initiatives, and the Pennsylvania Farm to School Network. There will be a PA HOM taste-testing opportunity.

Target audiences for these gatherings include Child Nutrition Program (CNP) operators, K–12 and early childhood education educators, producers, distributors, and other farm to school/early childhood education stakeholder groups.



These gatherings are being coordinated by the Pennsylvania Department of Education, Division of Food and Nutrition and Project PA (Penn State University). Funding is provided by a USDA Farm to School grant.

Check-in for each gathering will be from $8:30 \, \text{am} - 9:00 \, \text{am}$. Sessions will begin at $9:00 \, \text{am}$ and end at noon.

Get Ahead of Meal Debt

Unpaid meal debt in school nutrition operations had reached a crisis point even before the rise of COVID-19. Now, as districts begin a second year without the financial protection of federal waivers providing universally free meals—and as parents continue to face economic hardships in the wake of the pandemic and high inflation school nutrition directors are braced to contend with the consequences of meal charges. Positive, proactive strategies are critical—and <u>"Managing the Problem of Meal</u> <u>Debt,"</u> a new <u>SN Plus</u> article, identifies several steps.
